MINUTES OF THE NOVEMBER 25TH, 2013 PAMTA MEETING THE PIANO GALLERY

The meeting opened at 10:05 a.m. with President, Janet Dickerson, presiding. There were 18 members present.

The minutes of the October 28th, 2013 meeting were approved as read.

Revenue was \$20 in membership dues and \$100 for advertisement fees. Expenditures were for the October program presenter, flowers, printing of AIM certificates and Masquerade Musicale programs.

The Savings account as of 9/30/13 has \$8442.58.

<u>Recitals:</u> Rebecca Gebbink reported that there are slots available at Bass Pro Shops from 2:00 - 2:30, 6:00 - 6:30, and 7:00 - 8:00 on Saturday, December 7th. She mentioned that there will be a merry-go-round near where the piano will be.

<u>Brochures:</u> Janet Dickerson reported that PAMTA brochures are being printed and will be available at Bass Pro on December 7th.

<u>AIM:</u> Pam Eyerly reported that 117 students participated in the fall AIM Theory exams. She brought the finished exams to hand out to those teachers who had not yet picked them up, and asked that people let her know if there were any errors.

<u>Programs:</u> Brenda Conroy passed around a sign-up sheet for the December luncheon which will be at Biaggi's December 16th at 11:30. She also had registration forms available for the Duet Festival which will be held on February 8th. She then reminded everyone about playing a favorite piece for the program in January. Information about pedaling from Susan Tang's seminar at State Conference was handed out by Brenda also.

<u>New Business:</u> Janet read a letter from the President of ISMTA about sales tax having to be charged now on AIM materials. Pricing is displayed on the ISMTA website. <u>Announcements:</u> Pam Eyerly announced the Prairie Winds concert to be held at Metamora High School on Friday, December 13th.
